It is learnt that annuity has not been released pending clearance from Vigilance Department due to a pending CBI case against the officer that is still under process.

We request you to kindly instruct the concerned officials to interpret the transparent rules accordingly and release the annuity payments to Sri Adhikari without further delay.

Sub: Release of Annuity under CIL Defined Contribution Pension Scheme

I retired as Chief Manager (Personnel & Admin) on 31-05-2018 from JK Ropeways, Kajora Area of ECL on attaining the age of superannuation. My EIS No is 90137498 and I was a member of CIL Defined Contribution Pension Scheme. The amount of corpus under the Scheme till 30th September 2017 in my name is Rs.1299070. This amount has been remitted to Life Insurance Corporation of India on 04-06-2019 after deducting Income Tax. As required under the Scheme I have filed my profile form which is not yet accepted by the Nodal Officer and I am yet to get my annuity payments. On inquiry I was informed that the annuity is not released as vigilance clearance has not been received.

I was under suspension during the period August 2017 to January 2018 pending departmental enquiry. I was allowed to re-join duties in February 2018 with imposition of minor penalty of "Withholding of 1 increment without cumulative effect". A case is being conducted by CBI against me based on the same charges for which departmental inquiry was held. It is common knowledge under law that a man cannot be held guilty twice for the same charges.

I have retired under the normal course and have undergone the punishment awarded to me on the findings of the departmental enquiry. The stoppage of annuity under the Pension Scheme is totally unjustified as there is no clause in the said Scheme that prevents payment of annuity to me and vigilance clearance is not required.

I appeal to you to kindly release the annuity to me immediately so that I can meet my financial requirements post retirement.
